Our Highest and Lowest Placement Scores by Central Placement

According to the ÖSYS placement results announced by the Measurement, Selection and Placement Center Presidency in 2019 under the Finance, Banking and Insurance Department, the student with the highest 314,967010 points was placed, while the lowest placed student with a score of 196.031270. is entitled. While the occupancy rate of 40 student quotas opened in the year he started his education life was 100% completed, 33 students continue their education with an occupancy rate of over 80% in our program today.

Finance, Banking and Insurance department, "Banking and Insurance" program students are trained for 2 years (4 semesters) with theoretical and practical courses related to professional life within the framework of both academic and ethical principles, with the equipment needed by the sector. In order to transform the theoretical knowledge they learned in this process into practical knowledge, they are subjected to 30 working days of compulsory internship training. In addition, technical trips are provided to the extent required by the profession and opportunities allow the sector to be closely known.

Of course, in addition to all these, social activities such as folk dances, instrument courses such as baglama or guitar, and football tournaments for male students are held in order to support and contribute to the social and cultural development of students.
